


**RESOLUTION PETITIONING MORGAN COUNTY'S UNITED STATES CONGRESSMEN, REPRESENTATIVE CHUCK FLEISCHMANN, SENATORS LAMAR ALEXANDER AND BOB CORKER, TO REMOVE TAX PAYER MONIES FROM PLANNED PARENTHOOD ABORTION CENTERS**

**WHEREAS, Fifty-eight million (58,000,000) babies have been murdered in abortion clinics since the 1973 Roe v. Wade decision of the United States Supreme Court, and**  
**WHEREAS, Planned Parenthood is our nation's largest abortion provider, and**  
**WHEREAS, Planned Parenthood receives \$523,000,000 (523 million dollars; a half a billion dollars) each year of tax payer money, and**  
**WHEREAS, the Center for Medical Progress has released videos clearly and unequivocally revealing leaders of Planned Parenthood negotiating prices to sell the body parts of murdered/aborted babies, and**  
**WHEREAS, it is clearly discernable that Planned Parenthood systemically trafficks in human babies' body parts, and**  
**WHEREAS, federal law expressly forbids buying or selling human body parts, and**  
**WHEREAS, 42 U.S. Code 274e states, "Buying and selling human body parts is a federal felony, and**
