#1 – Approval of Minutes and Financial Statements

Executive Langley asked Landon Mann, Agriculture Educator of the Morgan County Vocational Technical Center and member of Soil and Water Conservation board to make his presentation. Mr. Mann stated that he wanted to explain what the Soil Conservation office does. It educates citizens on good farming practices. Help teach fencing, water land facilities, feeding paths, water conveyance, etc. They are needing some additional funding to help with a school farm project. Executive Langley asked them to come back during the budget process in May.

<u>#8 – Motion – Budget Amendment 116-4 – Sanitation Management</u>

Commissioner Roberts made a motion to approve budget amendment 116-4 Sanitation Management in the amount of \$24,500.00 for purchase of truck and trailer, Commissioner Justes seconded.

#10 – Approval of Transfer of Tribal Consistency Funds

Commissioner Roberts made a motion to approve the transfer of the Tribal Consistency Funds of \$50,000.00 to another line item to cover some expenditures as needed, Commissioner Morgan seconded.

<u>#11 – Surplus Equipment from Highway Department</u>

Commissioner Roberts made a motion to approve the surplus of equipment from Highway Dept.as a donation to the City of Wartburg, Commissioner Hennessee seconded.

#12 – Surplus Equipment from Sheriff's Department

Commissioner Roberts made a motion to approve the surplus of equipment from Sheriff's Dept.as a donation to the Chestnut Ridge Volunteer Fire Dept., Commissioner Hennessee seconded. This is 2014 Chevrolet Tahoe.

<u>#13 – Motion – Adjust the Contract for Food Service at the Jail</u>

Commissioner Roberts made a motion to approve the partial contract until June 30, 2023, with a 20% increase, however there will not be another increase for next year so this price will continue until June 30, 2024, Commissioner Bryant seconded.

Commissioner Anderson stated that they held a meeting on February 13 and elected officers as well as look into the RV Park and the environmental impact study.

Litter Committee

Commissioner Gibson stated that they held a meeting on March 9 and discussed some properties that have potential health hazards from the garbage piled in the yards. The committee is checking with the cities in the county on their regulations to see if the county can develop a policy. The committee will get back when they have something to bring to commission.
