Randy Anderson – Asked about road repair by CUB on road in Petros. Executive Langley stated that he would follow up with CUB.

#1 - Approval of Minutes and Financial Statements

Motion made by Commissioner Roberts and seconded by Commissioner Justes to approve the October 9, 2023, minutes.

#2 - Notaries - Ciara Barksdale, Rhonda Laughter

Motion made by Commissioner Justes to approve the aforementioned notaries applicants; Commissioner Roberts seconded.

Motion passed unanimously. (16/0)

Executive Langley introduced Mike Monroe, PUD General Manager. Commissioner Lively asked Mr. Monroe to appear and explain the sewer issues. He explained that the sewer system is under a sort of moratorium and cannot make any new connections until certain I&I problems are repaired and the plant can handle the flow coming into the system. He presented some options to help with community growth. He also explained that a grant has been applied for and approved but the money has not come in yet to do the repair work on the sewer system. After they receive the money work will begin, however, the time frame will depend on weather and conditions and then the system has to go through some rainy seasons to make sure the repairs are adequate before the (somewhat) moratorium will be released. If waivers could be asked for by commission that might help.

#3 - Motion - To Prepare a Resolution Concerning the Sewer System

Commissioner Lively made a motion to prepare a resolution asking for help with the sewer system and new connections, Commissioner Kreis seconded.

Executive Langley presented a plaque to Chad Sills as Region II Paramedic of the Year. This is a great honor. Executive Langley stated that he is very proud of Chad's accomplishments and his service to Morgan County.

Executive Langley asked about Juneteenth Holiday. Commissioner Snow has some ideas about on how the county could give the holiday in place of a raise or in addition to a smaller increase in salary. Discussions were held and will continue to look at this in the future.
