#10 - Motion - Budget Amendment 131-5 - Highway & Bridge Maintenance

Commissioner Roberts made a motion to approve budget amendment 131-5 in the amount of \$455.00, Commissioner Justes seconded. Sale of recycled materials.

#11 - Motion - Budget Amendment 151-1 - Other Debt Service

Commissioner Roberts made a motion to approve budget amendment 151-1 in the amount of \$23,272.11, Commissioner Snow seconded. Repayment of Property taxes to Knox Energy

Motion passed unanimously. (16/0)

#12 - Motion - Budget Amendments #42-#49 for BOE

Commissioner Roberts made a motion to approve budget amendment #42-#49 for Board of Education, Commissioner Hennessee seconded.

Motion passed unanimously. (16/0)

Commissioner Roberts stated that the lawsuit that Knox Energy had brought against the county was lost. The County will now have to repay \$385,000.00 to Knox Energy. There may be a way to appeal against this decision and the county is looking into it. Senator Yager is going to try and help with this. This will hurt our county landowners.

#13- - Motion - To Approve Sheriff's Department to Surplus Vehicle

Commissioner Roberts made a motion to approve the Sheriff's Dept to surplus 1994 Dodge Durango to Courthouse., Commissioner Bryant seconded.

Motion passed unanimously. (16/0)

Solid Waste

Commissioner Jackson along with Solid Waste Director Keith Kilby stated that they held a meeting February 26 to discuss a few things and make the following recommendations:

- 1. Change a part-time employee to full-time employee
- 2. Increase Attendance wages by \$7,500.00
- 3. Implement a charge for picking up cardboard at business locations
- 4. Charge Schools for trash, cardboard pickups

#14 – Motion to Approve the Solid Waste to Begin Charging School System for Trash and Cardboard Pickup

Commissioner Jackson made a motion to approve an increase in charges to schools from \$20,000.00 annually to \$\$50,000.00 annually, Commissioner Kries seconded.

Motion passed unanimously. (16/0)

#15 – Motion to Approve Changing the Part-time Employee to a Full-time Employee

Commissioner Jackson made a motion to make the part-time employee a full-time employee at a cost of \$16,800.00 and add \$7,500.00 to the Attendant line in the budget, Commissioner Roberts; seconded. These increases will be paid for by the increase in charges for schools and businesses.

Motion passed unanimously. (16/0)

#16 - Motion - To Begin Charging Businesses for Cardboard Pickup

Commissioner Jackson made a motion to begin charging businesses for cardboard pickup, Commissioner Justes seconded.

Motion passed unanimously. (16/0)

Building Committee

Commissioner Morgan stated that a meeting was held March 4. The sidewalks have been completed. They also discussed getting bids to pave the parking lot behind Wilson building and Annex. They are also wanting to give the sheds to Solid Waste because of the issues they have caused with inmates. They have also been working with ETHRA to spruce up the building and ETHRA has agreed to purchase new windows for the building at a cost of \$14,900.00. They are also looking into pressure washing the building to make it look better.
